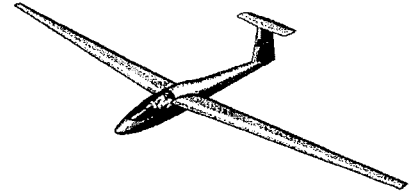
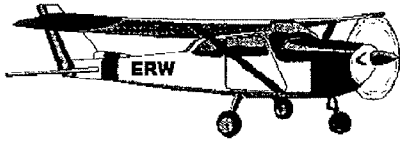

MEMBERSHIP APPLICATION FORM

I hereby make application to be enrolled as a Student / Associate / Flying Member (delete two) of the Central Otago Flying Club Inc. and agree to be bound by its Rules, Flying Rules and Regulations.

In consideration of the Club permitting me to take control or partake in a flight or flights (whether as Pilot, Pupil, or Passenger) in all Aircraft in the possession or hire of the Club, I agree to proceed on any such flight at my own risk, and I further agree:

- 1: That neither the Club or its Officers or Servants shall be liable for any personal or material loss or damage suffered by me or my dependents or any other person during or in consequence of or by reason of any such flight whether caused by the act, default, negligence or lack of skill of Clubs' Officers, Servants or Agents, or by any defect in the Clubs' equipment or otherwise howsoever whether under the Deaths by Accident Compensation Act, 1908, or any Act in lieu thereof or in alteration thereto at common law or otherwise howsoever and not withstanding that such injury, loss or damage may have been foreseeable.
- 2: That I and my heirs and executors will indemnify the Club against any such claims for any loss or damage.
- 3: That I will, at the request of the Club, make good to it any loss or damage occasioned to it, its Aircraft or property by reason of my acts, negligence or failure to obey the Rules, Regulations and by-laws of the Club, or the instructions, directions or orders of the Clubs Captain, instructors, Officials, Servants and Agents.
- 4: That I will require every person whom I take as a passenger for any such flight before leaving the ground to sign the Clubs' Official Form of Indemnity.
- 5: That I will pay to the Club on demand the fees from time to time prescribed for instructions or for the use of the Clubs' Aircraft and property, Club Bank account No is: 02 0916 0000609 00
- 6: That I will at all times be subject to and obey the Rules, Regulations and by-laws of the Club, and the instructions, directions and orders of the Club Captain, Instructors, Officials, Servants and Agents.
- 7: That the Club may at any time, and without assigning any reason, refuse to instruct me or permit me to fly in the Clubs' Aircraft.
